Task 2:

CONFIDENTIALITY AGREEMENT

This agreement is made and held on February 28, 2020 (next up “Effective Date”) by and between XYZ Company, the company that legally arranged and established based on Republic of Indonesia’s law, with the headquarter placed at xxxxxxxxxxxx st. (“First Party”) and 123 Company, the company established in Singapore and based at xxxxxxxxxxxx st. (“Second Party”).

THAT *The First Party* and *The Second Party* (“Both Parties”) intend to participate in the discussion and undertake efforts to enable either party to provide other Party with information

that is considered as closed and confidential by the informative Party ("Confidential Information"); and

HEREBY IT IS AGREED as follows:

1. When it is notified that Confidential Information disclosed by other Parties is closed and confidential, the information recipient ("Recipient of the Information") must, for a period of two years since date of the disclosure, stay away from disclosing the Confidential Information to any contractor or other third parties without a written agreement beforehand from the informing party and have to protect the Confidential Information from accidental disclosure to a third party by applying a level of caution and perseverance as well as applied the same for the Recipient to protect their own closed information and confidential, but in no case less than the proper level of caution.
2. The confidentiality provisions in this Agreement will remain in effect regardless of the termination of this agreement and the obligation of the receiving party to maintain the confidentiality of the information, the secret remains in effect until the confidential information no longer qualifies as a trade secret or until the information provider gives the recipient a written rebuttal or until the informing party provides the recipient with written notice releasing the recipient and this agreement, whichever occurs first.
3. Despite of provisions above, The Parties agree that information will not be considered as Confidential Information and The Recipient will have no obligation to maintain confidentiality of the information if the information is disclosed in accordance with laws, regulations, legal proceedings, or court order, or order from a government agency or other supervisors.
4. This Agreement shall be governed by, and construed in accordance with, the laws of Republic Indonesia, and any disputes arising in connection with this Agreement will be resolved by consensus.
